2. TPA Admin Services Agreement

> The attached draft Admin Services Agreement has been revised to simplify and streamline the relationship between a city and the TPA:

- Each city provides the TPA with a loan of \$300,000 which the TPA retains for a period of five (5) years
- The TPA uses these funds pay agency operating costs and then obtains reimbursements from federal planning grants
- The TPA pays each city an administrative fee of \$6,000 per year
- The TPA provides each city with an audited financial statement annually

Presently, this agreement has been shared with six municipalities for potential action by their local boards: Boca Raton, Jupiter, Palm Beach Gardens, Royal Palm Beach, Wellington and West Palm Beach.
