





#### REGULAR ITEMS

Mayor Haynie called the meeting to order at 9:04 a.m.

#### 1.A. Roll Call

The recording secretary called the roll. A quorum was present as depicted in Exhibit A of these Minutes.

1.B. Prayer - Led by Mayor Fred Pinto

#### 1.C. Pledge of Allegiance

MAYOR HAYNIE welcomed Mayor Shelly Petrolia, City of Delray Beach, and Council Member Jeremy Rodgers, City of Boca Raton to the meeting as new Board Representatives.

#### 1.D. ADOPTED: Agenda for April 19, 2018

MOTION to ADOPT the Agenda for April 19, 2018. Motion by Commissioner Burdick, seconded by Mayor Pinto, and carried unanimously 15-0. Mayors Gerwig, McKinlay, Triolo and Wilson, Council Member Hubbard and Commissioner Ryan were absent.

#### 1.E. APPROVED: Minutes for March 15, 2018

MOTION to APPROVE the Minutes for March 15, 2018. Motion by Mayor Petrolia, seconded by Mayor Marino, and carried unanimously 15-0. Mayors Gerwig, McKinlay, Triolo and Wilson, Council Member Hubbard and Commissioner Ryan were absent.

#### 1.F. Comments from the Chair and Member Comments

Mayor Haynie commented as follows:

On Friday, April 20, she will be participating in a group hosted by the United States
Department of Transportation through the White House to discuss infrastructure funding
opportunities. She attended previously when the President rolled out the infrastructure
announcements, and noted that because of her role as Chair of the Florida Metropolitan
Planning Organization Advisory Council (MPOAC) she is included in these meetings. She
will keep all abreast of any information regarding funding opportunities for Florida and
Palm Beach County.

• The June MPOAC meeting will be held in Orlando, and in conjunction with the National Association of Regional Councils (NARC) Conference.

There were no member comments received.

Mayor Anne Gerwig joined the meeting at 9:08 a.m.

#### 1.G. Executive Director's Report

Mr. Uhren reviewed the following from the report provided to the Board:

- The TPA will be hosting a condensed local version of the MPOAC Institute on May 7 from 9 a.m. to 12:00 p.m. at the Flagler Gallery in West Palm Beach. A more intensive version is held twice yearly, with Mayors Marino and Flores scheduled to attend later this year.
- The cities of West Palm Beach and Lake Worth are anticipated to issue their notices of establishment for a Florida East Coast Railway (FEC) quiet zone this Friday, April 20, which would make these quiet zones effective May 11, 2018. Brightline recently notified the TPA that they would complete the necessary Supplemental Safety Measure (SSMs) in Lantana, Hypoluxo, Boynton Beach, Delray Beach and Boca Raton by mid to late May. The TPA is actively working with their partners to expedite the completion of this work and facilitate issuance of the remaining notices of establishment.
- South Florida Commuter Services is hosting a commuter challenge throughout April with the Florida Department of Transportation (FDOT) and its transportation partners challenging commuters to use alternative modes of transportation. To participate, please visit www.sflcommutes.com
- The TPA will again collaborate with the West Palm Beach Downtown Development Authority (DDA) to provide a free bike valet service outside a main SunFest entrance gate at Clematis Street.
- The MPOAC meeting will be held in conjunction with NARC's Annual Conference in Orlando, Florida from June 3-6. This event is co-hosted by two Florida MPOs - MetroPlan Orlando and the Broward MPO, and features a diverse slate of expert panels, educational sessions, and keynote presentations. If interested in attending please contact the TPA as there is a travel budget that supports at least one Governing Board member to attend.
- On April 13, 2018 the Grand Classica, a 1,680-passenger cruise ship, joined its sister ship Grand Celebration at the Port of Palm Beach.
- Mr. Jeff Livergood, Public Works Director for the City of Boynton Beach, will be retiring
  at the end of April. He has served as Chair on the TPA's Technical Advisory Committee
  (TAC) from 2015-2017, and the TPA appreciates his service and valuable contributions.

Mayor Pam Triolo joined the meeting at 9:12 a.m.

• The TPA is seeking a Lead Planner to serve as the Pedestrian-Bicycle Coordinator and a Planner II to support the program management team. He expressed his appreciation to Mr. Tim Verbeke, who is leaving the TPA for another job opportunity in Chicago.

A discussion ensued regarding Brightline's testing on the FEC corridor in the Miami-Dade region and the impacts on Tri-Rail service.

COUNCIL MEMBER KURETSKI suggested the public be informed that although the obligation for the conductor to use the train horn is removed with a quiet zone, they can still use it if they deem appropriate. A discussion ensued on the local MPOAC Institute training and if it is only for Board members that have not attended a weekend training previously. Staff noted that they encourage all to attend as it a great learning experience, even if members have previously attended a MPOAC training.

Council Member Lynne Hubbard joined the meeting at 9:20 a.m.

MOTION to APPROVE the Consent Agenda. Motion by Mayor Pinto, seconded by Mayor Marino and carried unanimously 18-0. Mayors McKinlay and Wilson, and Commissioner Ryan were absent.

#### 1.I. General Public Comments

There were no general public comments received.

Commissioner Paula Ryan joined the meeting at 9:23 a.m.

#### 2. ACTION ITEMS

2.A. <u>APPROVED</u>: Amendment #4 to the FY 18-22 Transportation Improvement Program (TIP) to include the Florida Department of Transportation's (FDOT) request to advance the State Road 7 project from 60<sup>th</sup> Street to Northlake Boulevard

MR. UHREN stated the State Road 7 project, including the widening from Okeechobee Boulevard to 60<sup>th</sup> Street and the construction of a new roadway from 60<sup>th</sup> Street to Northlake Boulevard, is the Board's #1 Project Priority. He noted the project was fully funded in FY 17 in FDOT's Work Program but was not obligated, so FDOT is requesting the funding be rolled into FY 18. He noted the project has been advertised for construction, with bids due on April 25, 2018 and a contract is expected to be awarded shortly thereafter.

There was no discussion on this item.

MOTION to APPROVE Amendment #4 to the FY 18-22 TIP to include FDOT's request to advance the State Road 7 project from 60<sup>th</sup> Street to Northlake Boulevard. Motion by Commissioner Abrams, seconded by Commissioner Berger, and carried 16-3 with Commissioners Neering, Ryan and Waldron dissenting. Mayors McKinlay and Wilson were absent.

**2.B.** <u>ADOPTED</u>: Resolution Establishing a Policy for Subsidy Awards of Transportation Related Activities

MR. UHREN stated the desire of the TPA is to be an effective partner for transportation related events within the community, and to promote the visibility and opportunities for members of the community to get involved in the agency's decisions. He noted an effective way to accomplish this goal is to act as a sponsor or co-supporter of transportation related events. He noted the request before the Board is to designate authority to the Executive Director to commit the agency to sponsor activities, initiatives and/or events that align with the mission and purpose of the TPA, with an amount not to exceed \$2,000 per event. He noted the TPA has identified certain standards and conditions that would need to be present in any subsidy award agreement and anything above \$2,000 would come before the Board for approval.

A discussion ensued on the limit of events chosen.

MR. UHREN clarified that the subsidy awards given would be consistent with the line item budget for the use of local membership dues that will be approved by the Board at a future meeting. He noted this would come in FY19 when member dues are in place with an established budget for sponsorship events.

MOTION to ADOPT a Resolution Establishing a Policy for Subsidy Awards of Transportation Related Activities. Motion by Mayor Grant, seconded by Commissioner Ryan, and carried unanimously 19-0. Mayors McKinlay and Wilson were absent.

#### 3. INFORMATION ITEMS

3.A. <u>DISCUSSED</u>: Palm Tran Route Performance Maximization (RPM) Update

MR. CLINTON FORBES, Palm Tran's Executive Director, introduced this RPM update. He thanked the TPA staff for their collaboration over the last few years and for being major stakeholders in this project. He provided a high-level overview of the project's history, and noted the direction given by the Board of County Commissioners (BCC) was to use existing resources, of about \$100 million annually, to enhance the existing network. He stated the BCC also expressed the need to expedite this project from the original scheduled implementation date of February 2019. He welcomed the project manager along with consultants from Tindale-Oliver and Adams Consulting.

MR. KHALED SHAMMOUT, Palm Tran's Director of Transit Planning and project manager, noted the RPM's purpose and objective. He reviewed the proposed scenarios that derived from a preliminary report provided by Jarrett Walker & Associates, with the recommendations of either ridership improvements or an enhanced coverage option. He noted the BCC's direction to move forward with the enhanced coverage option and expedite the process. He reviewed the Phase II goals of making improvements to the network route alignments, schedules, stops locations, travel times, and additional public outreach and involvement. He briefly highlighted the RPM steering committee agency partners and consultant teams, the project timeline, outreach activities and bus wrap.

A lengthy discussion ensued with board members raising municipality specific concerns and requests for additional coordination to ensure their concerns are met. The Board requested a copy of the presentation given and the aforementioned Jarrett Walker reports. The Board inquired of future phases that include bus shelter improvements and payment options. Palm Tran staff and consultants noted they would be coordinating with each municipality in the coming months to ensure all concerns are heard and addressed.

#### 3.D. DISCUSSED: Partner Agency Updates - Turnpike

To accommodate Mr. Paul Wai's schedule, Mayor Haynie allowed for this item to be heard ahead of Items 3.B and 3.C.

MR. UHREN introduced Mr. Paul Wai, the new Director for Florida's Turnpike Enterprise. He mentioned the Turnpike Enterprise in Palm Beach County is expected to make a \$2 billion investment in their system capacity in the next 5-10 years.

MR. PAUL WAI noted that although he is housed in the Orlando office, he is a lifelong South Florida resident and expressed his knowledge of the mobility challenges of people and goods. He stated that being a part of the Turnpike since the mid-90's he commends the leadership of Palm Beach County for having the vision and discipline as it relates to development and the balance of mobility of people and goods in the Turnpike corridor.

#### 3.B. DISCUSSED: TPA Transition Steering Committee Update

MAYOR HAYNIE noted that in the agenda packet a chart was included showing where the TPA is in the process of transitioning to an independent agency. She reviewed the milestones from TPA Resolution 2017-08 that outline actions, estimated completion dates, and status.

MR. UHREN noted that the agenda packet also included a TPA Member Dues and Admin Services Tracking document, which outlines where each municipality stands in regards to municipality board action date and their interest in providing the TPA administrative services. He stated if any municipality would like himself or another TPA staff member to make a presentation to their boards to let him know.

A discussion took place on the status of which municipalities are interested in providing a line of credit; a suggestion for a more explicit explanation to municipalities that the TPA is seeking a loan and it has restrictions; clarification that an annual internal audit will still take place with the Board receiving an update of the findings; and that additional information is forthcoming regarding TPA staff benefits.

MR. UHREN provided an update on the potential TPA office space, which will be in the downtown West Palm Beach area and friendly to all modes of transportation. He noted the preliminary list of locations would be shared with the Transition Steering Committee to understand and for them to make a recommendation to the full board for a lease agreement.

#### 3.C. DISCUSSED: TPA Board Handbook and Member Profiles

MR. UHREN noted the TPA committed through its Strategic Plan to provide an updated handbook every March/April to coincide with the municipal elections, in order to provide every new elected official serving on the Governing Board with information about their roles and responsibilities. He gave a brief overview of the handbook contents and noted it includes a high-level overview of what the TPA does, partner agency contact information and a glossary.

MR. UHREN stated another resource provided are Member Profiles, which is a list of demographic information, stats, as well as maps of transportation facilities and their uses within each of the member communities.

#### 3.D. <u>DISCUSSED</u>: Partner Agency Updates - County Engineering

MR. DAVID RICKS, Palm Beach County Engineer, noted his office and Palm Tran are working collaboratively in the update to the County's 5-year road program.

#### 4. ADMINISTRATIVE ITEMS

#### 4.A. March's Public Involvement Activity Report

#### 4.B. Next Meeting - May 17, 2018 in Boynton Beach

MAYOR FLORES thanked the Mr. Uhren for following up on a concern raised at the previous meeting for a Greenacres middle school that currently does not have a 20 mph speed zone. He noted he received news yesterday that the issue will be addressed. He also thanked Ms. Valerie Neilson, TPA Deputy Director of Multimodal Development, for her presentation on the TPA to Greenacres council members.

COMMISSIONER BURDICK noted the County is looking to implement overhead flashers at Hidden Oaks and Roosevelt elementary schools. She thanked Mr. David Ricks for his work on these updates.

#### 4.C. Adjournment

There being no further business, the Chair declared the meeting adjourned at 10:33 a.m.
