construction of sidewalks at the following locations in the City of Belle Glade:

- 1. SW Avenue G: from SW 12th Street to SW 14 Street.
- 2. SE Avenue F: from Main Street to SE 7th Drive
- 3. NW 1st Street: from NW Avenue H to NW Avenue L/Gator Blvd.
- 4. NE 1st Street: from NW Avenue L/ Gator Blvd./ Airport Road to NE Avenue H
- 5. NE Avenue H: from Main Street/ SR-80 to NE 1st Street
- 6. NW 2nd Street: from CR-717 to NW Avenue H
- 7. SW 5th Street: from MLK Blvd to W Avenue A both sides of road
- 8. SW Avenue A: from SW 6th Street to Main Street- both sides of road
- 9. NE 1st Street: from N. Canal Street to NE Avenue F
- 10. SW 6th Street: from MLK Blvd. to Avenue A
