

RESOLUTION NO. 2022-3764

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF BELLE GLADE, FLORIDA, SUPPORTING THE FLORIDA DEPARTMENT OF TRANSPORTATION’S ESTABLISHED SAFETY TARGETS OF ZERO FATALITIES AND SERIOUS INJURIES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Federal Highway Administration (FHWA) performance measure implementation requires the Palm Beach Metropolitan Planning Organization (MPO), doing business as the Palm Beach Transportation Planning Agency (TPA), to establish federal Safety Targets by February of each year; and

WHEREAS, the TPA has the option to support the safety targets adopted by the State, or establish their own targets; and

WHEREAS, the Metropolitan Planning Organization Advisory Council (MPOAC), FHWA, the Florida Department of Transportation (FDOT), and numerous other federal and state agencies support “Vision Zero,” a multi-national strategy to eliminate all traffic-related fatalities and serious injuries; and

WHEREAS, since 2018 the TPA has annually chosen to support the FDOT-established safety targets of zero fatalities and serious injuries; and

WHEREAS, FDOT has established the following targets for 2022:

Performance Measure	2022 Target
Fatalities	0
Fatalities per 100 million vehicle miles traveled (VMT)	0
Serious Injuries	0
Serious Injuries per 100 million vehicle miles traveled (VMT)	0
Pedestrian and Bicyclist Fatalities and Serious Injuries	0

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF BELLE GLADE, FLORIDA, THAT:






SECTION 1. The foregoing recitals are hereby adopted and declared to be true and correct and are incorporated herein.

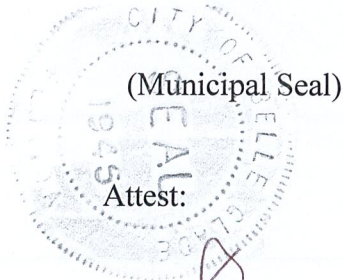
SECTION 2. The Belle Glade City Commission hereby:

- a. Supports the FDOT safety targets for 2022;
- b. Supports TPA staff to integrate these targets into the Long-Range Transportation Plan (LRTP) and Transportation Improvement Program (TIP) as administrative modifications;
- c. Supports TPA’s direction to staff to continue implementing and evaluating the Vision Zero Action Plan; and
- d. Supports TPA staff to monitor the safety performance measures, report on progress, and recommend modifications to safety targets annually.


SECTION 3. This Resolution shall take effect upon adoption.


