DISTRICT FOUR PROJECT OVERVIEW

In FY 2019 and FY 2020, Florida's Turnpike Enterprise funded various major transportation infrastructure improvements in District Four. Notable projects include:

- Widening of the Turnpike Mainline / SR 91: Boynton Beach Boulevard / SR 804 to Lake Worth Road / SR 802 (FPN: 406144-1)
- Resurfacing of the Turnpike Mainline / SR 91: MP 81 to MP 88 (FPN: 437991-1); MP 118 to MP 138 (FPN: 437992-1); MP 138 to MP 153 (FPN: 437986-1)
- All-Electronic Tolling (AET) – Phase 5C on the Turnpike Mainline / SR 91: North of Sawgrass Expressway / SR 869 to South of Lantana Toll Plaza (FPN: 429339-4)
- All-Electronic Tolling (AET) – Phase 8 on the Turnpike Mainline / SR 91: South of Lantana Toll Plaza to Three Lakes Toll Plaza (FPN: 431737-1)

Florida's Turnpike Enterprise continues to make significant project investments in District Four. In FY 2021 through FY 2025, Turnpike projects total over \$1.3 billion within within Broward, Indian River, Martin, Palm Beach, and St Lucie Counties. This amount includes funding for minor projects that cross into other districts.

The project widens a segment of the Sawgrass Expressway / SR 869 from south of Sunrise Boulevard / SR 838 to south of Atlantic Boulevard / SR 814. The widening will increase the number of travel lanes from six to ten and will include two express lanes in each direction. Express lanes implementation is planned upon completion of both widening projects on the Sawgrass Expressway / SR 869 between south of Sunrise Boulevard / SR 838 (MP 0.5) and SR 7 (MP 18). Work includes pavement widening, reconstruction, milling and resurfacing, interchange improvements at Sunrise Boulevard / SR 838 (MP 1), Pat Salerno Drive (MP 2.5), Oakland Park Boulevard (MP 3), and Commercial Boulevard (MP 5), and a new interchange at NW 8th Street.

The project widens a segment of the Sawgrass Expressway / SR 869 from north of Atlantic Boulevard / SR 814 to SR 7. The widening will increase the number of travel lanes from six to ten and will include two express lanes in each direction. Express lanes implementation is planned upon completion of both widening projects on the Sawgrass Expressway / SR 869 between south of Sunrise Boulevard / SR 838 (MP 0.5) and SR 7 (MP 18). Work includes pavement widening, reconstruction, milling and resurfacing, and interchange improvements at West Sample Road / SR 834 (MP 11), Coral Ridge Drive (MP 14), and University Drive / SR 817 (MP 15). The project goes with 443956-1.

Widen the Turnpike Mainline / SR 91 from the West Palm Beach Service Plaza (MP 94) to North of Okeechobee Boulevard / SR 704 (MP 101) FPN: 406143-5

The project widens a segment of the Turnpike Mainline / SR 91 from the West Palm Beach Service Plaza to north of Okeechobee Boulevard / SR 704. The widening will increase the number of travel lanes from four to eight, and includes infrastructure improvements to accommodate the future implementation of express lanes. Work includes pavement widening, reconstruction, milling and resurfacing, bridge improvements, stormwater drainage improvements, and noise walls in qualifying areas. Interchange improvements at Southern Boulevard / SR 80 (MP 97), Jog Road (MP 98), and Okeechobee Boulevard / SR 704 (MP 99) are also being evaluated.

West Palm Beach Service Plaza Parking Improvements (MP 94) FPN: 442625-1

The project expands passenger car and truck parking at the West Palm Beach Service Plaza. The proposed concept will add approximately 30 northbound passenger car spaces, 40 southbound passenger car spaces, 20 truck parking spaces, and 50 feet of parallel / tandem truck parking space. The number of additional parking spaces and other details will be confirmed during the design phase of the project. Work includes concrete pavement design, potential Turnpike Mainline / SR 91 off-ramp realignment, pond reconstruction, roadside ditch reconstruction, and lighting improvements at the plaza.

Implement All-Electronic Tolling (AET) Phase 8 on the Turnpike Mainline / SR 91 FPN: 431737-1

The project implements Phase 8 of the overall program to convert the Turnpike System to a cashless, all-electronic toll collection system. The limits of the AET Phase 8 conversion project begin at Lantana Toll Plaza (MP 88) on the Turnpike Mainline / SR 91 in Palm Beach County, and extend north through Martin, St Lucie, Indian River, and Okeechobee Counties, to Three Lakes Toll Plaza (MP 236) on the Turnpike Mainline / SR 91 in Osceola County. Construction began in FY 2019 and the FY 2021 funding reflects the remaining cost to complete the project. The AET Phase 8 conversion project includes the removal and replacement of 30 ramp toll plazas and two mainline toll plazas with 12 new AET mainline toll gantries.
