The five year Transportation Improvement Program (TIP) implements projects in the adopted long range plan as identified in the MPO's adopted priority list and proposed by FDOT and other stakeholders. Transportation projects funded by federal, state and local sources for all modes of transportation are included. The TIP was distributed for review and public comment and is scheduled for adoption by the MPO on June 19.

B. <u>MOTION TO RECOMMEND ENDORSEMENT</u> of the updated SR 7 (Sample Rd to Glades Rd) Project Development and Environmental Study Recommendation

The Palm Beach MPO first adopted the addition of transit/special use lanes to this section of SR 7 as a priority in 2004. FDOT staff and consultants will present the project background, alternatives evaluated, and an update on the

recommended improvements. The FDOT draft work program (FY 2015-2015) includes design funding in FY 15 and construction funding in FY 19. The attachment will be provided at the meeting.
