2. ACTION ITEMS

- A. MOTION TO RECOMMEND ADOPTION of the FY 16-20 Transportation Improvement Program (TIP)

The draft FY 16-20 TIP for the Palm Beach MPO is attached as Exhibit A. This program was developed based on information provided from FDOT and various local sources and includes transportation projects funded by federal, state and local sources for all modes of transportation. Proposed modifications to the MPO sub-allocation of Surface Transportation Funding in FY 17 are attached as Exhibit B. The MPO Board can choose to adopt the program as presented in Exhibit A or to adopt the program with the modifications identified in Exhibit B.

- B. MOTION TO RECOMMEND ADOPTION of a Resolution Directing MPO Staff in the Development and Content of the Transportation Improvement Program

The attached resolution Draft MPO 2015-04 seeks to outline clear expectations for project funding and implementation by category in the development of future Transportation Improvement Programs. It also authorizes the MPO director and

staff to coordinate with FDOT in the annual development of the FDOT Draft Tentative Work Program and the MPO TIP.

C. MOTION TO RECOMMEND APPROVAL of amendment to the FY 15-16 Unified Planning Work Program (UPWP)

The MPO has been selected to participate in FHWA's Bicycle and Pedestrian Pilot Technology Count Program. This program will provide the MPO with \$20,000 to purchase and deploy counter technology to collect data throughout the county. In order to receive these funds the MPO must update the UPWP to reflect these newly added tasks.

D. MOTION TO APPROVE letter of support of Delray Beach 2015 TIGER Grant application

The City of Delray Beach requests support for the 2015 TIGER application, aimed to fund improvements and connections to their non-motorized bike network. This network is a key element of Delray's economic strategy to invest in an alternative transportation network, one based on human powered mobility, i.e., biking and walking. As in most cities where the car is king, sidewalks and bike paths are inadequate or non-existent, particularly for an environmentally conscious future. The City has developed a Bicycle-Pedestrian Master Plan which has been incorporated in its Comprehensive Plan, Land Development Regulations, and ordinances to address the imbalance between motorized and non-motorized transit, increasing non-automobile trips from 3% to over 20%.
