## Technical Advisory Committee Liaison's Report – March 7, 2018

1. **TPA Funding Programs Applications:** Eleven (11) Local Initiatives (LI) project applications requesting \$32,188,000 in federal funds, and eight (8) Transportation Alternatives (TA) applications requesting \$6,147,740 in federal funds were submitted. The total funds available are roughly \$20 million for LI and \$3.1 million for TA. Project proposals submitted are included on the following page.
2. **FDOT Public Workshop:** FDOT staff will be holding a public information workshop regarding the 95 Express Phase 3B-2 project from south of Glades Road to Linton Boulevard on Wednesday, March 14<sup>th</sup> from 5:30 to 7:30 p.m. at the Spanish River Library, 1501 Spanish River Blvd, Boca Raton. A presentation will be given at 6 p.m.
3. **March is Florida Bicycle Month:** The TPA encourages its municipalities to celebrate and promote safe bicycling during Florida Bicycle Month of March. 4. **Green Pavement in Bike Lanes:** Last month Palm Beach County submitted a request to FHWA for interim approval to use green colored pavement in bike lanes. The request extends to County roads as well as municipal roadways under Palm Beach County traffic control jurisdiction.
5. **Complete Streets Workshop:** The Palm Beach TPA will be hosting an all-day Smart Growth America Complete Streets Workshop on Wednesday, March 14<sup>th</sup> at Vista Center, 2300 N Jog Road, West Palm Beach, FL. The target audience is City, County and FDOT staff that want to learn more about implementing Complete Streets projects that are creative, cost-effective, and championed.
