- Re-elected Councilmember Maria Marino as Chair and Mayor Fred Pinto as Vice Chair
- Re-elected Councilmember Maria Marino as Delegate to the Southeast Florida Transportation Council (SEFTC) and Vice Mayor Robert Weinroth as Alternate Delegate
- Re-elected Vice Mayor Robert Weinroth as Representative to the Florida MPOAC Governing Board and Mayor Steven Grant as the Alternate Representative
- Adopted the 2045 Long Range Transportation Plan (LRTP) after removing the widening of Clint Moore Rd, Jog Rd, Old Dixie Highway, Palmetto Park Rd, Military Trail and Powerline Rd in Boca Raton; adding the widening of Donald Ross Rd from Prosperity Farms to US 1; and removing the SR 7 widening and new construction from Okeechobee Blvd to Northlake Blvd
- Adopted Amendment #3 to the FY 20-24 Transportation Improvement Program (TIP) modifying the limits of fiber optic cable and adding an environmental phase to a PBC signal connection project
- Received a summary of the 4-year Federal Certification of the Palm Beach TPA
