## When is a TIP Amendment needed?

- Add or delete a project
- Cost Increases more than 20% and \$2 million
- Changes to Scope of Work
  - Length change by ½ mile and 20%
  - Number of through traffic lanes

## Which projects does an Amendment impact?

- Only projects listed in the Amendment
- No other projects in the TIP are affected
