- 1. *TPA Staff Update:*** We are excited to welcome Melissa Murray as our new Public Relations Director and Cassidy Sparks as our new Public Relations Specialist. We look forward to their contributions as we work collaboratively to advance the TPA's mission and vision.
- 2. *Florida Bicycle Month Recap:*** May was National Bicycle Month. To celebrate it, TPA staff participated in the Love to Ride Challenge and rode a total of 724 miles, joining 1,165 participants from 71 other workplaces statewide. Throughout the month of May, the 266,236 miles rode led to 4,962 pounds of Carbon Dioxide emissions mitigated by use of bicycles as vehicles.
- 3. *Recent Transit Workshops:*** The Southeast Florida Transportation Council hosted a virtual workshop to discuss the future implementation of Commuter Rail on the FEC railway on April 30.
