2. ACTION ITEMS

A. MOTION TO RECOMMEND ADOPTION of the Final FY 22-26 Transportation Improvement Program (TIP) Resolution

The Draft Resolution and the Executive Summary for the FY 22-26 TIP are attached. The TIP is the five-year funding program for transportation projects in Palm Beach County. The TIP was developed in collaboration with FDOT and various local agencies and includes transportation projects funded by federal, state and local sources for all modes of transportation. The TIP reflects revenue expectations for the next five fiscal years and shows phases and funding sources by year for each project. 
