NIGHTTIME RAMP CLOSURES FOR PAVING OPERATIONS

- The **southbound off ramp** and **northbound on and off ramps** at Florida's Turnpike and Boynton Beach Boulevard will be closed, **9 p.m. until 5 a.m., Wednesday, Feb. 24**, for paving operations
 - Please note, the southbound on ramp is expected to close the following night, Thursday, Feb. 25, for paving operations
 - Should inclement weather delay operations, work will take place the following week.
 - The southbound and northbound ramps will not be closed at the same time; once southbound is completed, work will move to the northbound ramps
- **Motorists may detour via the southbound exit ramp to Lake Worth Road, west to SR 7/US 441, and south to Boynton Beach Blvd.**
- **Motorists traveling northbound on Florida's Turnpike may exit at Atlantic Avenue, west to SR 7/US 441 and north to Boynton Beach Boulevard**
- **Motorists traveling on Boynton Beach Boulevard may detour west to SR 7/US 441, north to Lake Worth Road, and east to Florida's Turnpike**
- Emergency responder access will be provided at all times during these operations.

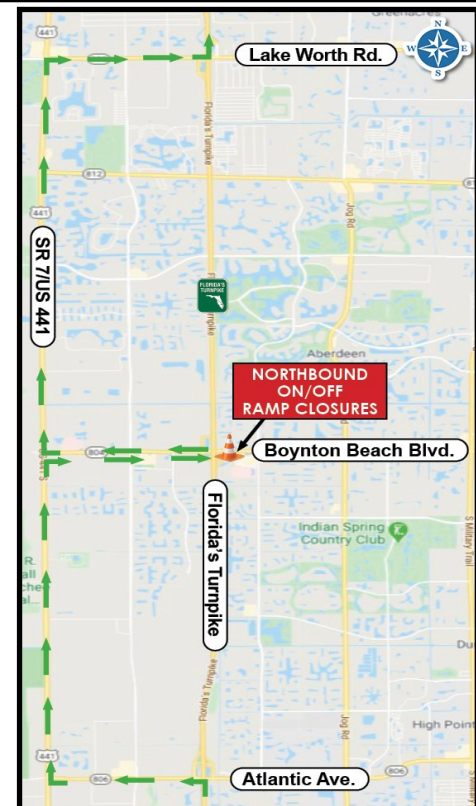
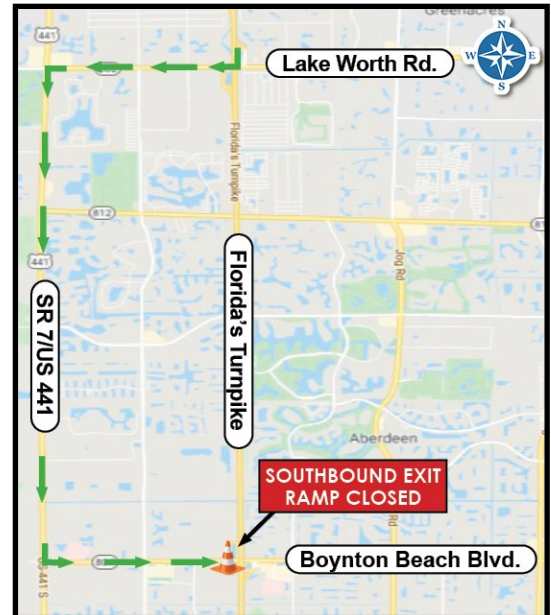
