

# Brightline Construction Advisory Lane Closure and Work Zone Updates for Orlando Extension (Phase 2 - South Florida to Orlando)

**ORLANDO, FI.** (May 10, 2021) – Brightline announces lane closures, work zone, railroad crossing and bridge work information for Phase 2 construction from Orlando to West Palm Beach, connecting Orlando to South Florida. Motorists and watercraft should proceed with extra caution through work zones and adhere to posted detour signs, speed limits and other signage. **Full closures** and **high-profile closures** are indicated in red. # <u>Eastbound and westbound Cargo Rd. between Bear Rd. and Casa Verde Rd. (north of Orlando International Airport)</u>

Extended single lane closure in each direction through Fall 2021 for bridge work. One lane will remain open in each direction.
